As we pen this letter, we would like to lead with gratitude for the dedication and humanity that has defined our journey through a uniquely challenging year. Never has there been a time when these qualities were more important. Credit unions were founded on the principle of *people helping people* and that's exactly what we did in 2020 and will always continue to do. It is difficult to believe that 2020 is behind us. It inspires us to reflect back and grasp the true meaning of being an essential business. We are proud to be a part of an organization that showed courage, strength, and initiative in the face of uncertainty, pain, and hardship. San Diegans proved to be a resilient group throughout the pandemic. As we worked together to navigate many obstacles, Wheelhouse Credit Union stepped up to ensure the financial and physical health of our institution and our Members. We hold all affected by COVID-19 in our hearts and we have faith that we will see much brighter days ahead.

All difficult situations have one commonality: the opportunity for growth and meaningful change. In 2020, we grew tighter as an organization and found safe ways to keep our doors open and care for our employees. By continuing to make our Members our highest priority, we helped them navigate through stressful and financially uncertain times, while ensuring they always had full access to their finances both through our branch network and online via digital banking.

Additionally, we prioritized our employees' health and emotional well-being throughout the pandemic. Following proper protocol and guidelines from the CDC, we rapidly supplied Personal Protective Equipment (PPE) to our team. This included plexi-glass barriers in the Branches, detailed signage at all locations, required temperature checks and questionnaires, work-from-home arrangements, and consistent safeguard communications. Our team, as always, stepped up with dignity and created a safe environment for all.

We are proud of the impact we made in our community by quickly putting together the Small Business Administration (SBA) Paycheck Protection Program (PPP) Loan plan, funding loans for small businesses in San Diego. We were able to expedite the program by taking immediate action, ultimately providing a total of 270 loans, equating to \$13.2M in support of local small businesses in need. We are pleased to continue our efforts in this area in 2021, as we move into offering loans during round two of this program.

Another way that we supported Members in 2020 was to reduce their monthly expenses through opportunities such as lower rate refinancing on auto loans with cash out, debt consolidation programs, and 0% balance transfer offers on credit cards. Members had full access to their accounts through our Digital Banking platform, allowing them to conduct transactions, monitor finances and apply for loans.

We are humbled by the kindness we witnessed coming from our Members, our Employees and the community as a whole, especially in relation to our first responders. To show our gratitude, we introduced our Badge of Honor College Scholarship Program, designed to help children/grandchildren of San Diego first responders. We hold our responsibility to our community in the highest regards and continue to invest in sustainability programs. We are proud to be the #1 Solar Financer in San Diego and appreciate providing our Members with a full suite of consumer products, including: checking, savings, auto loans, personal loans, recreational vehicle loans, home loans and more.

We may say that 2020 was an unprecedented year and that would be truthful. But it was also a remarkable one that helped to remind us of the most important things in life. We take the culture of our company very seriously, as it is that culture that allows us to serve you as best we can. It is our pleasure to do so and we look forward to providing you with thoughtful solutions and opportunities to help you meet your life goals. In response to the many small businesses who were having challenges securing SBA PPP Loans to help them stay afloat during the COVID-19 pandemic, we quickly built and launched a program that we specifically designed to help "true" small businesses throughout the San Diego community in their time of need.

We recognize the importance of small businesses in San Diego and felt a calling to support those who were being overlooked by larger financial institutions, ultimately providing resources to help our Members, friends, and neighbors stay financially stable during a very unstable time.

Early during the pandemic our executive team asked ourselves:

What can we do to help our local restaurants, childcare facilities, nail/hair salons, car washes and the many other businesses who felt a sharp decline in their revenue and/or were forced to close as a result of COVID-19? The answer was to step up and do something that we could all be proud of. So, we did just that, quickly launching a new SBA PPP Loan initiative that included advertising to small businesses in areas of need, building a user-friendly platform and servicing the requests through a dedicated team of professionals.

We are pleased to report that we accomplished our calling with flying colors and provided the following to San Diego Small Businesses during Round One of the SBA Paycheck Protection Program:

Early during the pandemic, we recognized the need to proactively identify opportunities for our Members to reduce their monthly expenses by:

- Approving loan deferrals
- · Waiving fees
- Offering lower rate refinance opportunities on auto loans with cash out options
- Providing debt consolidation programs to lower payments
- · Presenting 0% balance transfer offers on credit cards
- Offering financial consulting and education
- Serving small businesses through our SBA PPP Loan initiative

Operating as an Essential Business

As a financial institution, we operate as an essential business and take this responsibility seriously. During the pandemic, our Members had full access to our recently enhanced Digital Banking platform, giving them the ability to conduct transactions, monitor their finances and apply for loans from the safety and comfort of their home.

Our branches continued to operate to serve those who needed personalized attention, with enhanced safety protocols, including:

- Additional cleaning supplies and efforts
- Detailed communications on health practices
- Limited capacity
- · Plexi-glass, hand sanitizing stations, and distancing stickers
- Personal protective equipment for all employees





Looking Forward

California is the epicenter for sustainable energy innovation and adoption in the United States, and we expect that to continue as the government sets new standards for renewable energy and electric vehicles.
