Over the past nine decades, we remained committed to offering personalized service, innovative products, and attractive dividend-earning deposits. Our competitively priced loans and state-of-the-art digital and product enhancements ensure our Members have all the resources necessary to succeed.

In 2024, we enriched our suite of offerings by introducing Reverse, FHA and VA Mortgages, launching a new set of Youth Accounts, providing Will & Trust services, and pioneering an amazing new Inspired Plus Checking Account that comes with Cell Phone Insurance Coverage, Roadside Assistance, Fraud Prevention, Retail Discounts and more.

We enhanced our digital properties with new self-service features, including the ability to renew and roll over maturing certificates directly within digital banking, and introduced a new feature that allows Members to track their month-over-month debit and credit reward point earnings. Additionally, we refreshed our debit and credit card rewards redemption site to offer a more visually appealing and user-friendly experience.

As a leader in sustainability, we continue to empower our community to reduce their carbon footprint. As experts in Green Energy Lending, Wheelhouse is a leader in providing a full suite of Solar and Energy Efficient (EE) Loans, including Battery, Xeriscape, HVAC and more. In 2024, we continued to offer our Members a safe and secure place to put their deposits, earning dividends well over the national average. These initiatives resulted in Member share growth of 3.1%. Our Inspired Checking products continued to be a market leader, resulting in a 52% growth in balances. The Credit Union promoted our low introductory rate Home Equity Line of Credit in response to Members' needs to leverage equity in their homes, leading to a 43% increase in production compared to 2023.

Wheelhouse Credit Union has a stellar reputation in the community, supporting hundreds of organizations every year. 2024 proved to be a big year in contributions, as our financial donations, volunteer commitments and outreach elevated the communities in which we serve. D. Cruz Gonzalez Memorial Grant

Wheelhouse Credit Union recently presented its second annual D. Cruz Gonzalez Memorial Grant to Sports4Kids, a nonprofit organization dedicated to supporting local youth facing homelessness. The \$5,000 grant helped fund Bags of Hope care packages for unhoused students at Perkins Elementary School. Wheelhouse employees also volunteered at the event to assemble and distribute the packages. The grant, established in 2023 in memory of former Board Chair Daniel "Cruz" Gonzalez, honors his commitment to volunteerism and community outreach. The Trailblaze Challenge® San Diego, presented by Wheelhouse Credit Union, is an annual endurance event that combines physical achievement with philanthropic impact. Scholarship Programs



The Credit Union's annual College Scholarship Program was created in 2005 to support high school seniors in San Diego County. Wheelhouse has since expanded the program to support students committed to sustainability and family members of first responders.

Since 2020, The Badge of Honor Scholarship was added to honor first responders and their families, supporting high school seniors with a parent, grandparent or legal guardian who serve as an active member of law enforcement, fire protection service, healthcare or EMT in the San Diego region.

Since the creation of these programs, Wheelhouse has awarded \$126,000 in scholarships to local students, proudly investing in the futures of the next generation.



San Diego's Finest Leadership

Join us in congratulating Scott Wahl, a member of the Wheelhouse Credit Union Supervisory Committee since 2017, for being appointed as the City of San Diego's 36th Chief of Police on June 7, 2024. Chief Wahl oversees the police department for the eighth-largest city in the nation and is a fourth-generation San Diegan who grew up in the Clairemont community.

Supervisory Committee

The Wheelhouse Supervisory Committee is comprised of volunteer Members who independently evaluate internal controls ensuring they are followed by management. A primary responsibility of the Supervisory Committee is to hire an external audit firm to review the Credit Union's internal controls, financial statements, and to verify the loan and share accounts of our members. The Supervisory Committee engaged the national CPA firm, Turner, Warren, Hwang & Conrad AC (TWHC) to perform the Annual Financial Audit as of December 31, 2024. TWHC's responsibility, as prescribed by professional standards, is to express an opinion about whether the financial statements prepared by management with oversight are fairly presented, in all material respects, in conformity with accounting principles generally accepted in the United States of America.

The audited financials were presented to the Supervisory Committee and Board of Directors and filed with the records of the Credit Union, as well as submitted, as required, to State and Federal regulators. The Supervisory Committee is pleased to share that the audit report confirmed the Credit Union's financial statements for the year ended December 31, 2004 were materially correct and fairly presented in conformity with U.S. Generally Accepted Accounting Principles.
